**Subject:** Nominations for the BCLTA Board of Directors - Six Positions to be Elected in May 2007

### **To: Library Board Chairs and BCLTA Liaisons Please distribute to your boards**

Are you interested in taking your role as a trustee to the next level and serving on the board of the British Columbia Library Trustees' Association?

Now is the time to do it. This year there are six positions for election at our Annual General Meeting on May 11th. (You do not need to be present at the AGM to run.) The six positions are:

- President (a one-year term)
- Secretary Treasurer (a two-year term)
- Four Directors:
  - two positions for two year terms
  - two positions for one year

### **What is the work of the Board?**

BCLTA is governed by a Board of nine and is supported by an Executive Director and an Administrative Assistant. The mission of our organization is to "develop and support library trustees to advance public library service in BC." Our organization provides a range of services to trustees and boards to make them leaders in BC's library community such as conferences, workshops, bulletins, newsletters, etc.

BCLTA also fills an important strategic role providing organized representation to the provincial government levels of government and the public.

### **What commitment is involved to serve on the BCLTA Board?**

The Board meets approximately three times per year in the Lower Mainland - typically on a Saturday - plus there is an annual conference. As well, it is expected that board members can attend a few other key events throughout the year such as the Library Reception at the UBCM Convention in September and some of the main provincial government strategic plan symposiums. We try to share these responsibilities across all board members. Your expenses to attend meetings and events are fully covered by BCLTA.
